8 MOURNING THE DEATH OF Mr. ROBERT THOMAS ROLLER.

10 WHEREAS, we note the death of Mr. Robert Thomas
11 Roller of Bowdon, Alabama, on Wednesday, January 7, 2015, with
12 deep sadness and regret; his invaluable life of 69 years is
13 commended and celebrated with tremendous thanksgiving; and

14 WHEREAS, the passing of Mr. Roller leaves a void in
15 the lives of his loving family, many friends, and the entire
16 community, where he was highly regarded; and

17 WHEREAS, he was born January 24, 1945, in Sedalia,
18 Missouri, to the union of the late Robert Michael Roller and
19 Margaret Elizabeth Vile Roller Kriz; and

20 WHEREAS, upon graduating from Chilton County High
21 School in 1962, he entered the United States Marine Corps with
22 the intention of building a military career; however, his plan
23 was altered after he suffered major injuries during Vietnam;
24 and

25 WHEREAS, a squad leader with Company F, Second
26 Battalion, Fifth Marine Regiment, he was wounded three times

1 during a search and clear operation near the demilitarized
2 zone in Quang Tri Province on October 13, 1966; despite
3 incurring two injuries, he rendered first aid to the other
4 wounded Marines and organized the evacuation of his fallen
5 comrades; Sergeant Roller incurred his third wound, the one
6 that ended his career, when a bullet went through his hip,
7 flak jacket, cartridge belt, and out the other side; and

8 WHEREAS, notably, Mr. Roller received the Navy
9 Cross, the second highest medal a Marine can earn for heroic
10 actions while engaged in conflict; he was medically discharged
11 from the Marine Corps in 1968; and

12 WHEREAS, Mr. Roller earned a Bachelor's Degree in
13 Art Education in 1992 from the University of West Georgia; he
14 owned an art studio in Carrollton, Georgia, before moving to
15 Bowdon, Georgia, where he owned and operated the Potter's
16 Rhumb; he strove to help others better themselves and taught
17 educational classes to inmates at the Carroll County, Georgia,
18 Sheriff's Department; and

19 WHEREAS, survivors include his sister, Peggy Bishop;
20 and brother, George C. Roller; and

21 WHEREAS, Mr. Roller was a valued member of the
22 community; although his presence is greatly missed, his memory
23 is cherished in the hearts and minds of all those who were
24 fortunate enough to know him; now therefore,

25 BE IT RESOLVED BY THE LEGISLATURE OF ALABAMA, BOTH
26 HOUSES THEREOF CONCURRING, That while grieving the death of

1 Mr. Robert Thomas Roller, we are extremely grateful for his
2 abundant life, and we offer this resolution in highest tribute
3 to his inspiring legacy, as well as in heartfelt sympathy to
4 his family and friends.
