5 MOURNING THE DEATH OF U.S. SUPREME COURT JUSTICE  
6 ANTONIN GREGORY SCALIA.  
7

8 WHEREAS, with utmost reverence and respect, we mourn  
9 the loss of one of the greatest legal minds of our era and a  
10 dominant figure of the U.S. Supreme Court, Justice Antonin  
11 Gregory Scalia, who passed away February 13, 2016; and

12 WHEREAS, Justice Scalia's life journey began on  
13 March 11, 1936, in Trenton, New Jersey, as the only child of  
14 Salvadore Eugene and Catherine Panaro Scalia; he grew up in  
15 the neighborhood of Queens in New York City and was an  
16 accomplished student at the public elementary school he  
17 attended; he subsequently excelled at Xavier High School in  
18 Manhattan, a military school operated by the Jesuit order of  
19 the Catholic Church; and

20 WHEREAS, graduating with his Bachelor's Degree in  
21 History as valedictorian and summa cum laude from Georgetown  
22 University, Justice Scalia obtained his Juris Doctorate from  
23 Harvard Law School; he embarked upon his distinguished legal  
24 career in private practice in 1961; with a desire to teach, he  
25 shared his love and passion for jurisprudence as a professor

1 at the University of Virginia Law School and eventually the  
2 University of Chicago, where he was one of the first faculty  
3 advisors of the fledgling Federalist Society; and

4 WHEREAS, following Justice Scalia's service in the  
5 Nixon and Ford administrations, President Ronald Reagan  
6 recognized his intellect and pragmatism and appointed him as  
7 judge of the United States Court of Appeals for the District  
8 of Columbia Circuit in 1982; thereafter, President Reagan  
9 appointed him to the U.S. Supreme Court in 1986 and he was  
10 unanimously confirmed by the Senate as the first  
11 Italian-American Supreme Court Justice; and

12 WHEREAS, quickly establishing himself as the anchor  
13 of the court's conservative majority, Justice Scalia upheld  
14 the highest standards of ethics and unabashedly adhered to a  
15 set of steadfast core values and beliefs while administering  
16 the law with the utmost honesty, fairness, and integrity; and

17 WHEREAS, Justice Scalia was a staunch advocate of  
18 the judicial philosophy of originalism which stipulates that  
19 the Constitution should be interpreted according to the  
20 primary intent of its ratifiers in order to protect the basic  
21 fundamental rights of United States citizens; and

22 WHEREAS, from examination of the breadth of the  
23 Second Amendment to sympathy for states' rights, for almost  
24 three decades, Justice Scalia's eloquent, analytical opinions  
25 on major social and legal issues, as well as his barbed, witty

1       dissents in seminal cases before the highest Court in the land  
2       continue to shape jurisprudence in America; and

3               WHEREAS, the United States has lost a valuable  
4       member of the Judiciary; although his formidable presence will  
5       be greatly missed, his legacy remains forever etched not only  
6       in the annals of case law, but in the cornerstone of justice  
7       itself; now therefore,

8               BE IT RESOLVED BY THE LEGISLATURE OF ALABAMA, BOTH  
9       HOUSES THEREOF CONCURRING, That while grieving the death of  
10      Justice Antonin Gregory Scalia, we are extremely grateful for  
11      his contributions to this nation and state, and we offer this  
12      resolution in highest tribute to his inspiring legacy.
