11 WHEREAS, highest commendations are herein proudly
12 presented to City Councilwoman Georgette White Moon for
13 outstanding public service on the Tuskegee City Council on the
14 occasion of her retirement in 2016; and

15 WHEREAS, first elected to the Tuskegee City Council
16 in 2004, City Councilwoman Georgette White Moon has
17 demonstrated an unwavering commitment to credibility,
18 integrity, and accountability while representing District 3
19 during her consecutive four-year terms of leadership; and

20 WHEREAS, her service has been marked by remarkable
21 downtown improvements, the development of Washington Plaza
22 Shopping Center, an increased number of retail stores,
23 increased sales tax revenues, property abatement in several
24 neighborhoods, the establishment of Greenfork Playground, the
25 paving of streets in Greenfork, Gauthier, and Church Street
26 neighborhoods, drainage project at Freeman Plaza, and her

4 exceptional civic involvement includes her service on the

8 first African-American to teach at Punahou School in Honolulu,
9 which is a school President Barack Obama attended; and

10 WHEREAS, City Councilwoman Georgette White Moon has
11 earned numerous accolades including Teacher of the Year
12 Selection at Cora Kelly Magnet School in Alexandria, Virginia,
13 Team Teacher of the Year selection, Macon County Teacher of
14 the Year selection, Math and Science Teacher of the Year
15 selection, Iota Phi Lambda Outstanding Teacher of the Year
16 selection, and the Tuskegee Graduate Chapter Community Service
17 Award; and

18 WHEREAS, City Councilwoman Moon holds a Bachelor's
19 Degree from Alabama State University and a Master's Degree
20 from Michigan State University and pursued post-graduate
21 studies at Tuskegee University; she is an active member of the
22 Alpha Kappa Alpha Sorority, Inc., and of the Friends of the
23 Tuskegee Airmen National Historic Site and a faithful and
24 dedicated member of Bethel Baptist Church; and

25 WHEREAS, through the years, City Councilwoman Moon
26 has earned immense respect for her tireless dedication and
27 exceptional abilities; her unwavering commitment to excellence

1 in public service reflects immense credit upon Tuskegee and
2 the entire State of Alabama, and she is truly deserving of
3 special commendation and praise; now therefore,
