5 NAMING A PORTION OF INTERSTATE HIGHWAY 65 THE BUDDY
6 COX MEMORIAL HIGHWAY.

8 WHEREAS, in honor of the late B. E. "Buddy" Cox, who
9 served as State Materials and Tests Engineer for the Alabama
10 Department of Transportation, it is appropriate to name a
11 portion of Interstate Highway 65 between mile markers 246 and
12 247, the Buddy Cox Memorial Highway; and

13 WHEREAS, Mr. Cox held three degrees from Auburn
14 University and was named an Outstanding Bio-Engineering
15 Alumnus; he served 30 years with the United States Air Force
16 and Alabama National Guard, retiring as a Colonel; and

17 WHEREAS, Mr. Cox worked 17 years with the Alabama
18 Department of Environmental Management, and 25 years with the
19 Alabama Department of Transportation; due to his geotechnical
20 engineering expertise, in 2010 he was able to preserve a
21 stretch of I-65 by managing the assessment and repair of a
22 sinkhole; and

23 WHEREAS, Mr. Cox was known as a man of honesty,
24 wisdom, and integrity who loved serving God, his country, his

1 state, and his fellow man throughout his many years of
2 military and public service; now therefore,

3 BE IT RESOLVED BY THE LEGISLATURE OF ALABAMA, BOTH
4 HOUSES THEREOF CONCURRING, That in memory of B. E. "Buddy"
5 Cox, we declare that the portion of Interstate Highway 65
6 extending from mile marker 246 to mile marker 247 be named the
7 Buddy Cox Memorial Highway.

8 BE IT FURTHER RESOLVED, That the appropriate
9 officials be requested to place and maintain signs or markers
10 as provided in this resolution.
