8 EXPRESSING THE INTENT OF THE MAJORITY OF THE SENATE
9 IN COMMENDING PRESIDENT DONALD J. TRUMP ON HIS ELECTION AND
10 SWIFT ACTION TO FULFILL HIS CAMPAIGN PROMISES TO THE PEOPLE OF
11 THE UNITED STATES.

13 WHEREAS, Donald J. Trump was elected President of
14 the United States on November 8, 2016, and inaugurated on
15 January 20, 2017; and

16 WHEREAS, as a candidate, President Trump promised to
17 repeal costly regulations, put America first for jobs, protect
18 the unborn, and repeal and replace the Affordable Care Act;
19 and

20 WHEREAS, within the first few weeks of assuming
21 office, President Trump has signed executive orders that
22 fulfill those promises, including one executive order that
23 requires federal agencies to repeal at least two regulations
24 for every one new regulation proposed; and

25 WHEREAS, President Trump signed an executive order
26 to shorten lengthy permitting processes for businesses and to
27 jump start the Keystone XL and Dakota Access Pipeline, thereby

1 generating jobs and allowing the further expansion and
2 production of natural resources in the United States; and

3 WHEREAS, President Trump and the current
4 congressional leadership have begun the process of rolling
5 back the Affordable Care Act, which caused premium increases
6 and the elimination of many health plans, and forced patients
7 to replace trusted doctors with new and unfamiliar medical
8 practitioners; and

9 WHEREAS, an executive order was signed by President
10 Trump to reinstate the ban on United States taxpayer-funded
11 abortions overseas; and

12 WHEREAS, the junior senator from Alabama, Senator
13 Jeff Sessions, has been nominated for the position of United
14 States Attorney General; and

15 WHEREAS, Neil Gorsuch, an appellate judge from
16 Colorado who has been compared to the late Supreme Court
17 Justice Antonin Scalia, has been nominated to the United
18 States Supreme Court; now therefore,

19 BE IT RESOLVED BY THE SENATE OF THE LEGISLATURE OF
20 ALABAMA, That the 45th President of the United States, Donald
21 J. Trump, is hereby heartily commended and congratulated on
22 his election and immediate attention to reducing regulations,
23 utilizing American resources, restricting taxpayer money for
24 foreign abortions, beginning the process of repealing the
25 Affordable Care Act, and thereby, Making America Great Again.

26 BE IT FURTHER RESOLVED, That this body urges the
27 United States Senate to swiftly complete the process of

1 confirming Alabama Senator Jeff Sessions to the position of
2 United States Attorney General and Neil Gorsuch to the
3 position of United States Supreme Court Associate Justice.
