23 member of the Alabama Law Institute's Probate Code Revision
24 Committee, assistant to the Alabama Law Institute on numerous
25 projects relating to Alabama probate courts, probate law, and

1 probate practice and procedure, and as a frequent speaker at
2 seminars; and

3 WHEREAS, an avid learner of many subjects and a man
4 of various interests, he was an instrument rated airplane
5 pilot for many years and, today, enjoys photography,
6 astronomy, and birding; he is a licensed ham radio operator
7 and an honorary member of the Murphy High School Alumni Silver
8 Panthers Ham Radio Club; he and his wife, Wendy, are faithful
9 members of the First Baptist Church of Mobile; and

10 WHEREAS, the Mobile Bar Association's Probate
11 Section has scheduled a special reception honoring Joe
12 McEarchern on the occasion of his retirement; and

13 WHEREAS, through the years, Joe McEarchern has
14 earned widespread admiration and respect for his tireless
15 dedication and exceptional abilities, and he is truly
16 deserving of special commendation and praise; now therefore,

17 BE IT RESOLVED BY THE LEGISLATURE OF ALABAMA, BOTH
