3 MOURNING THE DEATH OF THOMAS EDWIN DRAKE.

5 WHEREAS, we deeply regret and are greatly saddened
6 to learn of the death of Thomas "Tom" Edwin Drake of Cullman,
7 Alabama, on February 2, 2017, at 86 years of age; and

8 WHEREAS, the passing of Thomas "Tom" Edwin Drake
9 leaves a void in the lives of his loving family, many friends,
10 and the entire community, where he was highly regarded; and

11 WHEREAS, born in Morgan County on December 5, 1930,
12 he was educated in Cullman County; he and his family made
13 their home in Vinemont, Alabama; and

14 WHEREAS, Tom Drake excelled in sports, obtaining an
15 athletic scholarship to the University of Tennessee at
16 Chattanooga, where he wrestled and played football for the
17 Chattanooga Mocs and was drafted to play professionally for
18 the Pittsburgh Steelers; and

19 WHEREAS, following an honorable discharge from the
20 United States Army, Mr. Drake he went on to become a
21 professional wrestler, head wrestling coach at The University
22 of Alabama and a member of the athletic staff under Coach Paul
23 "Bear" Bryant; and

1 WHEREAS, Tom Drake received his law degree from The
2 University of Alabama and practiced law in Cullman for more
3 than 50 years; and

4 WHEREAS, he represented the Cullman area for 32
5 years in the Alabama House of Representatives, winning his
6 first election in 1960 while still in law school; and

7 WHEREAS, Tom Drake served in the House for nine
8 terms, was Speaker of the House twice, and was floor leader
9 for Governors George Wallace, Lurleen Wallace, Albert Brewer,
10 Fob James, Guy Hunt, and Jim Folsom, Jr.; and

11 WHEREAS, he was instrumental in the development of
12 Wallace State Community College in Hanceville; the coliseum
13 bears his name and the baseball field, his wife's, Christine;
14 and

15 WHEREAS, Tom Drake was preceded in death by his
16 parents and his wife of 56 years, Christine McKoy Drake, also
17 an attorney, stateswoman, and former member of the Alabama
18 Board of Education; and

19 WHEREAS, survivors include his sons Thomas Edwin
20 Drake II (Kimberly) and G. Whit Drake (Katie); daughters Mary
21 Drake Pate and Christy Lee Drake Lowe; and seven
22 grandchildren; and

23 WHEREAS, Thomas Edwin Drake was a valued member of
24 the community; although his presence is greatly missed, his

1 memory is cherished in the hearts and minds of all those who
2 were fortunate enough to know him; now therefore,

3 BE IT RESOLVED BY THE LEGISLATURE OF ALABAMA, BOTH
4 HOUSES THEREOF CONCURRING, That while grieving the death of
5 Thomas "Tom" Edwin Drake, we are extremely grateful for his
6 abundant life, and we offer this resolution in highest tribute
7 to his inspiring legacy, as well as in heartfelt sympathy to
8 his family and friends.
