13 Basketball Team on winning the 2017 Sun Belt Conference
14 Championship; and

15 WHEREAS, the Troy University Women's Basketball Team
16 competes at the NCAA Division I level as a proud member of the
17 Sun Belt Conference; and

18 WHEREAS, on March 12, 2017, the Lady Trojans
19 defeated the University of Louisiana-Lafayette 78-64 at
20 Lakefront Arena in New Orleans, Louisiana, to capture its
21 second consecutive Sun Belt Conference Championship to earn a

8 Chanda Rigby, whose Trojan teams have posted three consecutive
9 seasons of 20 wins or more since she was named head coach five
10 seasons ago, including this season's 22-11 record; and
