8 COMMENDING JAMES ALEXANDER ARMSTRONG ON ATTAINING
9 THE RANK OF EAGLE SCOUT IN THE BOY SCOUTS OF AMERICA.

11 WHEREAS, commendations and congratulations are
12 extended to James Alexander Armstrong of Troop 130 of the
13 Greater Alabama Council on attaining the rank of Eagle Scout,
14 the highest rank in the Boy Scouts of America; and

16 small percentage of Scouts, involves the completion of an
17 Eagle Project and represents many years of diligence in
18 pursuit of a worthy goal that brings honor to the Scout, his
19 family, and his troop; and

21 Scouting from Cub Scout to Eagle Scout, meeting the demanding
22 requirements for achieving this coveted rank; in addition to

13 at Oxford Middle School in Oxford, Alabama; he is a school

17 those hard-won characteristics of trustworthiness,
18 self-discipline, and good citizenship, all components of the
19 Scouting program; with the guidance and support of his Scout
20 leaders, he has earned the esteem of his community, fellow
