8 RECOGNIZING ALPHA KAPPA ALPHA SORORITY,  
9 INCORPORATED, ON THE OBSERVANCE OF AKA DAY AT THE CAPITOL.

11 WHEREAS, Alpha Kappa Alpha Sorority, Incorporated,  
12 was founded on the campus of Howard University in Washington,  
13 D.C. in 1908; it is the oldest Greek-letter organization  
14 established by African-American college-educated women; The  
15 sorority has flourished into a globally-impactful organization  
16 of nearly 300,000 college-trained members in more than 1,000  
17 chapters in the United States, Liberia, the Bahamas, the U.S.  
18 Virgin Islands, Germany, South Korea, Bermuda, Japan, Canada,  
19 South Africa, and the Middle East; and

20 WHEREAS, the Opening Session for AKA Day at the  
21 Capitol will begin this year on April 23, 2019, with members  
22 of Alpha Kappa Alpha Sorority, Incorporated, connecting with  
23 Regional and International officers, Community Leaders, and  
24 Legislators to discuss current legislation and take action  
25 through Voter Engagement and Advocacy Activities; this session  
26 will be held at 9:00 a.m. in Room 200 at the Alabama State  
27 House; The AKA Day session at the Capitol will rally around

1 the theme, "Take A.C.T.I.O.N: Through HBCUs and Economic  
2 Empowerment"; and

3 WHEREAS, the sorority has a Legislative Agenda for  
4 the 2019-2020 sessions which includes Federal and State  
5 Funding for education, assess to Healthcare, Economic  
6 Empowerment, Voting Rights, Criminal Justice Reform, fair  
7 presentation and access to the Arts; Alpha Kappa Alpha Day at  
8 the Capitol is the primary vehicle used to display our  
9 position of membership strength and provide members with an  
10 opportunity to engage Elected Officials at the State Level;

12 WHEREAS, this is the first AKA Day at the Capitol in  
13 the Southeastern Region under the Sorority's International  
14 Theme, "Exemplifying Excellence through Sustainable Service,"  
15 introduced by the current International President, Dr. Glenda  
16 Glover; the 26th South Eastern Regional Director, Attorney  
17 Mitzi Dease Paige, leads the region which consists of three  
18 states Mississippi, Alabama, and Tennessee; the Regional AKA  
19 Day at the Capitol Liaison is Leyser Q. Hayes, Esq; the State  
20 Coordinator is Pamela Hudson Pruitt; the Alabama Liaison is  
21 Dr. Barbara Boyd and Melissa McNeil Hammonds is the AKA Day at  
22 the Capitol Resource; the Southeastern Representative to the  
23 International Connection Committee, Ms. Juanda Maxwell will  
24 also attend the event; this event will include members  
25 attending the Opening of the Legislative Session and  
26 Legislative Committee Meetings; the day will conclude with  
27 Constituent Visits and a Tour of the Capitol; now therefore,
