3 MOURNING THE DEATH OF MRS. JACQUELYN DYAR THOMPSON.

5 WHEREAS, it is with profound sorrow that we note the
6 death on February 13, 2019, of Mrs. Jacquelyn "Jackie" Dyar
7 Thompson of Enterprise, Alabama, at the age of 78 years; and

8 WHEREAS, her passing leaves a void in the lives of
9 her loving family, many friends, and the entire community,
10 where she was highly regarded; and

11 WHEREAS, Mrs. Thompson was born to James Guy and
12 Eleanor Searcy Dyar; and

13 WHEREAS, affectionately known as Grandmother, Ms.
14 Jackie, and Big Jack to many, Mrs. Thompson was a lifetime
15 resident of Enterprise, Alabama; she loved her family and her
16 community; and

17 WHEREAS, she worked hard, and she loved expanding
18 her knowledge and being involved in the workplace and in her
19 community; as a teenager, she worked in her father's shirt
20 factory, Searcy Company; later, she became a co-owner of local
21 retail shops, the Tree House and Bromberg's; also, she managed
22 Westgate Shopping Center, worked as a bookkeeper for Easy Pay
23 Tire Store, and worked as an agent for Century 21 for 27
24 years; furthermore, she was one of Enterprise's best
25 ambassadors, she served as President of the Wiregrass Board of

1 Realtors in 1997, and she received the Realtor of the Year
2 Award in 1998, along with numerous other awards throughout the
3 years; and

4 WHEREAS, in 1984, Mrs. Thompson became a member of
5 the Enterprise City Council; in 1989, she was appointed as the
6 first female Mayor of Enterprise; in 1990, she was chosen as
7 Enterprise's Woman of the Year; and

8 WHEREAS, she was a lifelong member of First Baptist
9 Church, a member of the Phyllis Talmadge Sunday School Class,
10 one of the first members of the Twentieth Century Misses
11 Chautauqua Club, and an active member of the Twentieth Century
12 Chautauqua Club; also, she was a strong supporter of the
13 Enterprise Recreational Center; and

14 WHEREAS, Mrs. Thompson served on various boards and
15 committees; she served as the Board President of the YMCA from
16 1983 to 1984, and she served on the Coffee County Family
17 Services Board as well; and

18 WHEREAS, she was preceded in death by her parents,
19 James Guy and Eleanor Searcy Dyar; and brother, Jim Dyar; and

20 WHEREAS, Mrs. Thompson is survived by her husband,
21 Harrell Thompson; children, Robert Harrell Thompson, Jr.,
22 Terri Averett (Bruce), Jim Thompson (Bev), and Greg Thompson
23 (Jodee); grandchildren, Hadley Thompson McAlister (Brandon),
24 John Robert Thompson, Ashley Averett, Eric Averett, Sid
25 Thompson, Ele Thompson, Stacy Lin Thompson, and Dyar Thompson;

1 great-grandchildren, Finley Kate McAlister and Eason
2 McAlister; and a host of cousins; and

3 WHEREAS, although her presence will be greatly
4 missed, the memory of Mrs. Thompson will be cherished in the
5 hearts of all who knew and loved her; now therefore,

6 BE IT RESOLVED BY THE LEGISLATURE OF ALABAMA, BOTH
7 HOUSES THEREOF CONCURRING, That the death of Mrs. Jacquelyn
8 "Jackie" Dyar Thompson is recorded with deep sadness, and this
9 resolution is offered in tribute to her life and with
10 heartfelt sympathy to her family, whose grief is shared by
11 many.
