8 MOURNING THE DEATH OF LIEUTENANT COLONEL ROBERT
9 MARSHALL, USMC (RETIRED) .

11 WHEREAS, it is with profound sorrow that we note the
12 death on April 20, 2019, of Lieutenant Colonel Robert William
13 Marshall, USMC (Retired) of Huntsville, Alabama, at the age of
14 58 years; and

15 WHEREAS, he was born on October 31, 1960, in
16 Washington, D.C., to Dr. John and Frances Marshall; and

17 WHEREAS, a graduate of Bishop McNamara High School
18 in Maryland, Lieutenant Colonel Marshall accepted a NROTC
19 Scholarship to Texas A and M University, where he earned a
20 Bachelor's Degree in Mechanical Engineering; he earned a
21 Master's Degree in AeroNautical Engineering from the Naval
22 Post Graduate School in Monterey, California; and

23 WHEREAS, he served as a United States Marine Pilot
24 for 21 years; after retiring from the Marine Corps, he worked
25 as an engineer with Aerodyne and Torch Technologies; and

26 WHEREAS, Lieutenant Colonel Marshall was extensively
27 engaged in the community and his church; he was a mentor to

1 young men, invested in small group ministry and youth groups
2 in every church he attended around the world; he was
3 co-founder of the Semper Fi Community Task Force, President of
4 the Madison County Military Heritage Commission, and still
5 serving on the boards of Veterans and Christian Women's Job
6 Corps; and

7 WHEREAS, survivors include his beloved wife of 29
8 years, Mrs. Jana Jones Marshall; son, Samuel Lee Andrew
9 Marshall; daughter, Carolyn Grace-Marie Marshall; mother,
10 Frances Rader Marshall; sisters, Jeneanne Rae (Eugene),
11 Christine Magee (Jim), and Anne Marie Walker; brother, Jim
12 Marshall (Robin); and a host of other family and friends; and

13 WHEREAS, although his presence will be greatly
14 missed, the memory of Lieutenant Colonel Marshall will be
15 cherished in the hearts of all who knew and loved him; now
16 therefore,
