3 NAMING THE CROSSWALK ON SHADES CREEK PARKWAY IN
4 JEFFERSON COUNTY THE KENNETH SHERWOOD EBAUGH MEMORIAL
5 CROSSWALK.

7 WHEREAS, Mr. Kenneth Sherwood Ebaugh was born on
8 July 24, 1951, in Birmingham, Alabama, to Reverend John Lynn
9 Ebaugh, III, and Joy Richard Ebaugh; he graduated from
10 Birmingham-Southern College in 1973, where he was a member of
11 Theta Chi fraternity; he earned an MBA from The University of
12 Alabama at Birmingham in 1979, and retired as a Vice President
13 of Regions Bank; and

14 WHEREAS, he was a firm believer in continuing
15 education; he was the first person in 21 years to win both the
16 Highest Grade Award and the BankSim Presidents' Award from the
17 Alabama School of Banking in 1996; he believed strongly in
18 public service and served proudly as a Past President of the
19 Kiwanis Club of Homewood and Mountain Brook, where he was a
20 member for more than 40 years; he was the recipient of the
21 prestigious George F. Hixon Fellowship, which recognizes those
22 who have contributed significantly to the Kiwanis Club's
23 history of generosity; he was also a member of the Ensley
24 Rotary, as well as other civic organizations; he attended St.
25 Stephens Episcopal Church in Vestavia Hills; and

1 WHEREAS, the death of Mr. Ebaugh on January 28,
2 2019, is recorded with deep sadness, and it is befitting to
3 memorialize his many contributions to the community and this
4 state; now therefore,

5 BE IT RESOLVED BY THE LEGISLATURE OF ALABAMA, BOTH
6 HOUSES THEREOF CONCURRING, That we declare that the crosswalk
7 crossing Shades Creek Parkway at the entrance to Brookwood
8 Mall in Jefferson County, be named the "Kenneth Sherwood
9 Ebaugh Memorial Crosswalk."

10 BE IT FURTHER RESOLVED, That the appropriate
11 officials be requested to place and maintain signs or markers
12 as provided in this resolution.
