3 MOURNING THE DEATH OF MRS. JUDY KAY SASSE HAISE.

5 WHEREAS, it is with profound sorrow that we note the
6 death on January 17, 2021, of Mrs. Judy Kay Sasse Haise of
7 Mountain Brook, Alabama, at the age of 77; and

8 WHEREAS, her passing leaves a void in the lives of
9 her loving family, many friends, and the entire community,
10 where she was highly regarded; and

11 WHEREAS, born and reared in Cheyenne, Wyoming, Mrs.
12 Haise served as Honored Queen of Job's Daughters and rode
13 calves in the Cheyenne Frontier Days Rodeo, becoming a Junior
14 Champion Barrel Racer, when she was young; and

15 WHEREAS, she graduated from The University of
16 Wyoming, where she majored in English and Journalism and was a
17 member of The Student Senate, Alpha Chi Omega Sorority, and Pi
18 Delta Epsilon Honorary Collegiate Journalism Fraternity; her
19 first job after graduation was at the Army Language School in
20 Washington, D.C., where she met Jim Haise, who was a Captain
21 in the United States Army Special Forces; 10 months later,
22 they married and moved to the Panama Canal Zone, where Mr.
23 Haise was stationed; and

24 WHEREAS, some of Mrs. Haise's accomplishments during
25 her journalism career included uncovering, investigating, and

1 reporting on the theft of some of the Valley Forge Park's
2 treasured and protected walnut trees by a local contractor;
3 and serving as Women's Editor for the Shades Valley Sun
4 (Birmingham, Alabama), as Fashion Writer for Parisian, Inc.
5 (Birmingham, Alabama), and as TV Magazine Editor for The
6 Orange County Register (Santa Ana, California); additionally,
7 she was Social Scene Columnist and Neighborhoods Columns
8 Editor and Social Writer at The Birmingham News (Birmingham,
9 Alabama) for 25 years; and

10 WHEREAS, some of the services she performed in her
11 community included serving as past President of The
12 Antiquarian Society, past Vice President of the Daffodils of
13 Mountain Brook Garden Club, and founding member of The Women's
14 Foundation of the Symphony Volunteer Council; also, she
15 received numerous awards throughout her life, including, but
16 not limited to, earning First Place in the California Press
17 Women's Annual Awards and being named the Social Writer
18 Extraordinaire by the Cahaba Valley Sertoma Club; and

19 WHEREAS, Mrs. Haise is survived by her husband of
20 nearly 55 years, Jim Haise; daughters, Jennifer Neil (Cary)
21 and Julia Holt (Matt); granddaughters, Caitlin Holt Cole
22 (Matt), Jessica Holt, and Katherine Neil Alldredge (Jimbo);
23 and grandson, Haise Ogilvie; and

1 WHEREAS, although her presence will be greatly
2 missed, the memory of Mrs. Haise will be cherished in the
3 hearts of all who knew and loved her; now therefore,

4 BE IT RESOLVED BY THE LEGISLATURE OF ALABAMA, BOTH
5 HOUSES THEREOF CONCURRING, That the death of Mrs. Judy Kay
6 Sasse Haise, is recorded with deep sadness, and this
7 resolution is offered in tribute to her life, along with
8 heartfelt sympathy to her family, whose grief is shared by
9 many.
