8 MOURNING THE DEATH OF MR. AUBREY REGINALD MIREE, JR.

10 WHEREAS, it is with profound sorrow that we note the
11 death on April 6, 2021, of Mr. Aubrey Reginald "Reggie" Miree,
12 Jr. of Huntsville, Alabama, at the age of 96; and

13 WHEREAS, his passing leaves a void in the lives of
14 his loving family, many friends, and the entire community,
15 where he was highly regarded; and

16 WHEREAS, Mr. Miree was born on October 5, 1924, in
17 Birmingham, Alabama, to Grace Northcutt and Aubrey R. Miree,
18 Sr.; and

19 WHEREAS, Mr. Miree opened multiple businesses
20 throughout his career, his first one being K and M Paint and
21 Glass Company, which he opened with his business partner, Tom
22 Knight, in Huntsville in 1952; active in the Huntsville
23 community, Mr. Miree was appointed to the Huntsville City
24 Planning Commission Board; helped found Peoples National Bank
25 (now known as Wells Fargo), where he was a long-term board
26 member; served in the Kiwanis Club; served the ACME Club,
27 where he was President for one term; served on the Huntsville

1 YMCA Board and at Camp Cha-la-Kee; and was active in the
2 Democratic Party, where he ran local campaigns and was a
3 member of the President's Club, under President Lyndon B.
4 Johnson; and

5 WHEREAS, Mr. Miree was an avid golfer and spent many
6 happy Thursday afternoons with friends at the Huntsville
7 Country Club; some of his best memories were made during
8 summers at his lake cabin in Guntersville, Alabama, where he
9 entertained family and friends with boating, skiing, swimming,
10 and fishing; and

11 WHEREAS, he is survived by his wife of 76 years,
12 Dorothy McKemie Miree; children, Dr. Lucia Miree, Marian Miree
13 Bevel, and A.R. "Trey" Miree, III (Charlotte Walton);
14 grandchildren, Jessica Bevel Entrekin (Adam), Alexandra Miree,
15 and Brandon Miree; great-grandchild, Miller Mac Entrekin; and
16 a host of additional relatives, close friends, and dear
17 caregivers; and

18 WHEREAS, although his presence will be greatly
19 missed, the memory of Mr. Miree will be cherished in the
20 hearts of all who knew and loved him; now therefore,
