11 WHEREAS, highest congratulations are herein proudly
12 presented to Sophia Dailyn Swann for being crowned Miss
13 Alabama Teen USA 2021; and

14 WHEREAS, in January 2021, 41 young women from around
15 the state competed for the title of Miss Alabama Teen USA 2021
16 at the Auburn Hotel Grand Ballroom; the preliminary
17 competition began on the 9th, and the interviews and the final
18 competition were held on the 10th; contestants for Miss
19 Alabama Teen USA are judged in three categories, namely
20 interview, athletic wear, and evening gown, with each counting
21 for 33 percent of each contestant's score; as Miss Alabama
22 Teen USA 2021, Dailyn will represent the state when she
23 competes for the title of Miss Teen USA at the River Spirit
24 Resort and Casino in Tulsa, Oklahoma, from November 26-28,
25 2021; and

26 WHEREAS, a native of Greenville, Alabama, Dailyn is
27 a 2020 graduate of Greenville High School; she obtained 29

1 college credits through dual enrollment courses during her
2 high school years; from 2017 to 2020, she was an ambassador
3 for the City of Greenville's Chamber of Commerce as a Camellia
4 Girl; during her senior year, she worked part-time at the
5 Sellers Law Firm and The Clothes Tree by Deborah; she
6 completed her junior year and senior year simultaneously to
7 graduate with honors a year early; and

8 WHEREAS, immediately following her high school
9 graduation, Dailyn moved to Birmingham, Alabama, with her
10 older sister, Sellers, who is a first-year medical student at
11 The University of Alabama, School of Medicine; in the fall of
12 2021, Dailyn plans to attend The University of Alabama at
13 Birmingham and double major in Political Science and Spanish
14 on the Pre-Law track; her goal is to become an attorney who
15 focuses on human rights and immigration law; furthermore, her
16 passion for immigration stems from her love for her two
17 brothers from Honduras, Dony and Cristian, who came to the
18 United States at the ages of 15 and 16 and eventually became a
19 part of the Swann family; witnessing her brothers' immigration
20 process has motivated her to advocate for people who wish to
21 become citizens of the United States; and

22 WHEREAS, currently, Dailyn works full-time as a
23 fashion consultant for The Clothes Tree by Deborah; in her
24 spare time, she enjoys collecting vintage vinyl records from
25 various genres, baking desserts for Saint Anne's Women's Home,
26 and walking her two maltipoos through Highland Park in
27 Birmingham; and
