11 WHEREAS, as technology continues to progress and new
12 kinds of threats arise around the world, cybersecurity is
13 playing an increasingly central role in our national security
14 and daily lives; and

15 WHEREAS, the State of Alabama recognizes that it has
16 a vital role in identifying, protecting, and responding to
17 cyber threats that may have a significant impact on our
18 citizens' security and privacy; and

19 WHEREAS, critical infrastructure sectors are
20 increasingly reliant on information systems and technology to
21 support financial systems, energy, telecommunications,
22 transportation, utilities, health care, and emergency response
23 systems; and

24 WHEREAS, cybersecurity education and awareness are
25 crucial for everyone, including large corporations, small
26 businesses, financial institutions, schools, government

1 agencies, the home user, and anyone who connects to the
2 Internet; and

3 WHEREAS, the State of Alabama is proud of the steps
4 we have taken to promote technological innovation and bolster
5 cybersecurity measures; and

6 WHEREAS, the State of Alabama is dedicated to
7 providing our citizens and public and private organizations
8 with the resources necessary to ensure the understanding,
9 implementation, and success of National Cybersecurity
10 Awareness Month and to help ensure that Alabamians stay safe
11 online and connect with confidence; and

12 WHEREAS, the "Stop. Think. Connect." trademarked
13 campaign serves the national cybersecurity public awareness
14 campaign and is implemented through a coalition of private
15 companies, nonprofit and government organizations, and
16 academic institutions that work together to increase the
17 understanding of cyber threats; furthermore, the trademarked
18 campaign empowers the American public to be safer and more
19 secure online; and

20 WHEREAS, maintaining the security of cyberspace is a
21 shared responsibility in which each of us has a critical role
22 to play; awareness of computer security essentials will
23 improve the security of Alabama's information, infrastructure,
24 and economy and will help attain a safer, more secure, and
25 more resilient cyber world; now therefore,

26 BE IT RESOLVED BY THE LEGISLATURE OF ALABAMA, BOTH
27 HOUSES THEREOF CONCURRING, That we do hereby recognize October

1 2021 as National Cybersecurity Awareness Month; we urge
2 Alabama's citizens, companies, and institutions to recognize
3 the importance of cybersecurity and to observe this month
4 through events, training, and education that will further our
5 country's national security and resilience; we commit to
6 ensuring our nation's cybersecurity, and we raise awareness of
7 the responsibility that all Americans have to protect their
8 Internet-connected devices, technology, and networks from
9 cyber threats at work, home, and school.
