11 WHEREAS, we take great pride and pleasure in
12 congratulating Miss Emee Baldwin on being crowned Miss River
13 City 2020; and

14 WHEREAS, the accomplished Houston, Alabama, native
15 is a graduate of The University of Alabama in Huntsville with
16 a Bachelor of Science Degree in Nursing; Miss Baldwin is
17 privileged to be one of 43 women competing in the 2021 Miss
18 Alabama contest to be held June 10-12 at the historic Alabama
19 Theatre; and

20 WHEREAS, as a role model for young girls, Miss
21 Baldwin has many scholastic and athletic honors, including The
22 University of Alabama in Huntsville's College of Nursing
23 Dean's List, Gold Award, Academic Excellence Award, UAH Pole
24 Vault Athletic Scholarship, the Gulf South Conference's
25 All-Academic Athlete, Addison High School Salutatorian,
26 Alabama Youth Tour Delegate, National Collegiate Athletic
27 Association Athlete, three-time Top Three Pole Vault Finisher

1 at the Gulf South Conference Championship; Multi-Sport State
2 Champion in Volleyball and Pole Vaulting, two-time Pole Vault
3 Alabama State Record Holder, and a Bryant-Jordan Scholar
4 Athlete; and

5 WHEREAS, Miss Baldwin is a passionate advocate for
6 patients' rights; her dear grandfather, Poppy, was diagnosed
7 and hospitalized with COVID-19; due to hospital regulations
8 during the pandemic, no visitors were allowed to see him; she
9 was finally able to visit the day he passed away, but it was
10 too late; knowing 10,000 Alabama families have been unable to
11 visit their loved ones, Miss Baldwin did not want this to
12 continue; she immediately and ardently began lobbying
13 Alabama's Legislature to draft a bill that would allow
14 patients and nursing home residents the right to have a
15 familiar face in the room with them; she created a petition
16 for Alabamians to sign that would guarantee this basic patient
17 right; she created her social impact initiative, Poppy's
18 Purpose, to ensure that patients and their loved ones would be
19 safe during visits; she has raised over \$5,000 to provide
20 masks and gloves for visitors in hospitals where needed; the
21 Legislature passed House Bill 521, the Harold Sachs Act, named
22 for her grandfather; and

23 WHEREAS, Miss Baldwin's future plans call for a
24 career as a Neonatal Nurse Practitioner; she has only just
25 begun her journey with patient advocacy; she plans to continue
26 to bring awareness to the critical need for patients to have

1 advocates and to provide care and opportunities for every
2 patient to understand the importance of holistic health; and

4 WHEREAS, with her compassion, strength of character,
5 and determination forged in tragedy, Miss Baldwin possesses an
6 inner grace and beauty that mirrors her external radiance; she
7 is an exemplary Alabama citizen who demonstrates leadership
8 qualities, skills, and talents bringing about effective change
benefitting all Alabamians; now therefore,
