3 MOURNING THE DEATH OF MR. LAWTON PRICE MILLER.

5 WHEREAS, it is with profound sadness that we note  
6 the death on January 18, 2022, of Mr. Lawton Price Miller of  
7 Birmingham, Alabama, at the age of 59 years; and

8 WHEREAS, his passing leaves a void in the lives of  
9 his loving family, many friends, and the entire community,  
10 where he was highly regarded; and

11 WHEREAS, Mr. Miller was a proud 1984 graduate of The  
12 University of Alabama, where he earned a degree in Public  
13 Relations and was a member of Sigma Chi Fraternity; and

14 WHEREAS, after graduation, he worked briefly for his  
15 late father, Gordon Wayne Miller, Sr. at Miller Sales Company;  
16 in 1993, he and his late brother, Gordon Wayne Miller, Jr.  
17 started Miller Valve and Controls, which they grew into a  
18 leading valve and actuation distributor and where Mr. Miller  
19 spent the remainder of his career; and

20 WHEREAS, Mr. Miller was a faithful and dedicated  
21 member of Mountain Brook Community Church and was eager to  
22 share his testimony about his faith in Christ; one of his  
23 favorite verses was Matthew 18:12, which reminds us that God's  
24 faithful pursuit of our hearts is like a man who will leave  
25 ninety-nine sheep to search for one that is lost; and

1               WHEREAS, he was preceded in death by his father,  
2       Gordon Miller; and brother, Wayne Miller; and

3               WHEREAS, survivors include his beloved wife, Brenda  
4       Justice Miller; daughters, Caitlin Miller Foley (Mark), Mary  
5       Claire Miller Cox (Walker) and Margaret Morgan Miller;  
6       stepson, James Daniel Justice II (Madison); grandchildren,  
7       Mary Lawton Foley and Emma Margaret Foley; mother, Marcia  
8       Wilkins Miller; brother, Stuart Beauregard Miller (Tara);  
9       nephews, Lawton Terrell Miller and Nicholas Duke Miller;  
10      nieces, Sally Anne Miller and Phoebe Marie Miller; and a host  
11      of other relatives and friends; and

12              WHEREAS, although his presence will be greatly  
13      missed, the memory of Mr. Miller will be cherished in the
