8 HONORING AND COMMENDING REPRESENTATIVE WES ALLEN FOR  
9 HIS DISTINGUISHED SERVICE TO THE HOUSE OF REPRESENTATIVES OF  
10 ALABAMA.

12 WHEREAS, we note with utmost admiration and  
13 appreciation the distinguished service of Representative Wes  
14 Allen to the Alabama House of Representatives, serving the  
15 constituents of House District 89 consisting of Dale and Pike  
16 Counties for the past 4 years; and

17 WHEREAS, Representative Allen was elected to the  
18 Alabama House of Representatives in November 2018 and is a  
19 resident of Pike County; Representative Allen earned his  
20 Bachelor's Degree from The University of Alabama, and a  
21 Master's Degree from Troy University; he played wide receiver  
22 at The University of Alabama under Head Coaches Gene Stallings  
23 and Mike Dubose; prior to being elected to the House of  
24 Representatives, he diligently served Pike County, Alabama, as  
25 Probate Judge beginning 2009, originally appointed by Governor  
26 Bob Riley and going on to win a term in his own right in 2012;  
27 Representative Allen is married to Cae Allen and they are

1 members of the First Baptist Church of Troy, where he serves  
2 as Deacon; Representative and Mrs. Allen have two children,  
3 Davis and DeeAna; and

4 WHEREAS, Representative Allen's Committee  
5 assignments in the Alabama House of Representatives include  
6 Vice Chair of the Constitution, Campaigns, and Elections  
7 Committee, Judiciary Committee, and Urban and Rural  
8 Development Committee; for the first time in the history of  
9 the State of Alabama, a father and son are serving in the  
10 Alabama Legislature simultaneously, as Representative Allen's  
11 father, Gerald Allen is a State Senator from Tuscaloosa; and

12 WHEREAS, Representative Allen believes in giving  
13 back to his community and is actively involved as a member and  
14 past President of Pike County Friends of the National Rifle  
15 Association, Alabama Farmer's Federation, Pike County  
16 Cattleman's Association, National Wild Turkey Federation,  
17 former President of the Alabama Judges Association, University  
18 of Alabama A-Club, Little League Coach for Pike County  
19 Recreation Center, and Leadership Pike-Class of 2005-2006; now  
20 therefore,

21 BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES OF  
22 THE LEGISLATURE OF ALABAMA, That this body hereby honors and  
23 commends Representative Wes Allen for his years of dedicated  
24 service to this body and to the entire State of Alabama.
