3 MOURNING THE DEATH OF MR. ROBERT MICHAEL BERRY.

5 WHEREAS, it is with profound sorrow that we note the
6 death on March 14, 2022, of Mr. Robert Michael "Mike" Berry at
7 the age of 64 years; and

8 WHEREAS, Mr. Berry was born on August 26, 1957, at
9 Macon County Hospital in Tuskegee, Alabama; he was currently
10 serving as the District 4 County Commissioner of Macon County
11 where he served for 29 years; and

12 WHEREAS, in addition to being a County Commissioner,
13 Mr. Berry served as a police officer in Notasulga, Tuskegee,
14 and Franklin Counties, and as a deputy sheriff of Macon
15 County; he was a school bus driver from the late 1970s to the
16 mid 1990s, and he worked for Alabama Department of
17 Transportation from the mid 1990s to 2003; and

18 WHEREAS, Mr. Berry was a faithful and dedicated
19 member of Liberty United Methodist Church in Notasulga; he was
20 also a supporter of Notasulga High School and Macon County; he
21 worked diligently for all citizens of Macon County; he never
22 met a stranger and loved everyone especially his
23 grandchildren; he enjoyed hunting and fishing, gardening, and
24 Notasulga High School and Auburn University Athletics; Mr.
25 Berry had a servant's heart; and

1 WHEREAS, he was preceded in death by his beloved
2 wife, Helen Berry; father, Wilbur Berry, and nephew, Allen
3 Berry; and

4 WHEREAS, survivors include his son, Russ Berry;
5 daughter, Dawn Godfrey (Neil); mother, Frances Berry;
6 siblings, Wilbur Berry (Linda) and Linda Hatchett (Ricky);
7 grandchildren, Walden Berry, Chloe Berry, Nick Clark, and
8 Haley Lott (Allen); great-granddaughter, Ella Mae Lott;
9 nephew, Michael Hatchett (Hanna); niece, Michelle Clayton
10 (Adam); and a host of other relatives and friends; and

11 WHEREAS, although his presence will be greatly
12 missed, the memory of Mr. Berry will be cherished in the
13 hearts of all who knew and loved him; now therefore,

14 BE IT RESOLVED BY THE LEGISLATURE OF ALABAMA, BOTH
