5 facility and learned about the stress and obesity rate among
6 African Americans; he then decided to start a class in the
7 urban area of Birmingham; on January 7, 2012, D2 Line Dancing
8 started at the Crescendo Bar and Lounge with seven eager
9 people participating every Monday and Wednesday night; in less
10 than five years, D2 Line Dancing was able to get the City of
11 Birmingham moving in an incredibly positive way; the program
12 has grown to well over 80 participants, now meeting at the
13 YWCA every Monday through Thursday; welcoming people of all
14 ages to join the fitness movement, D2 Line Dancing and its
15 team manage to be creative in the movements to keep the
16 classes flowing where there is something for everyone; and

17 WHEREAS, a remarkable inspiration indeed, Mr. Keith
18 continues to passionately teach and lead others; his steadfast
19 selflessness and commitment are deeply loved and appreciated
20 by many; now therefore,
