4 SJR\_\_\_ MOURNING THE DEATH AND CELEBRATING THE LIFE OF JAMES  
5 BUFORD BOONE, JR.

7 WHEREAS, it is with profound sorrow that we note the  
8 death of James Buford Boone, Jr. of Tuscaloosa and  
9 Lowndesboro, Alabama, on February 13, 2023, at the age of  
10 87; and

11 WHEREAS, his passing leaves a void in the lives of  
12 his loving family, many friends, and the Alabama communities  
13 where he was highly regarded; and

14 WHEREAS, Mr. Boone was born in Macon, Georgia, on  
15 November 25, 1935, to James Buford Boone, Sr. and Frances  
16 Herin Boone; he worked for his father's newspaper, The  
17 Tuscaloosa News, as a high school and college student; and

18 WHEREAS, Mr. Boone was a 1958 graduate of The  
19 University of Alabama School of Commerce and Business  
20 Administration; upon graduation, he worked with his mentor,  
21 Carmage Walls, holding positions with several Walls-owned  
22 newspapers and gaining valuable experience, particularly  
23 from the perspective of running the business side of  
24 publishing; and

25 WHEREAS, in 1968, Mr. Boone succeeded his father as

26 publisher of The Tuscaloosa News; over the following half  
27 century, he continued to build a media company that now owns  
28 or manages 91 newspapers, magazines, and other print media,  
29 as well as digital products in Alabama, Georgia, Kentucky,  
30 Louisiana, Michigan, Minnesota, Mississippi, North Carolina,  
31 Ohio, Tennessee, Texas, and Virginia; last year, the company  
32 changed its name to Boone Newsmedia, Incorporated to reflect  
33 the growth and variety of publications both digitally and in  
34 print; and

35 WHEREAS, over the years, Mr. Boone earned many  
36 accolades and awards including an Honorary Doctor of Humane  
37 Letters from The University of Alabama (UA); the Julia and  
38 Henry Tutwiler Award from UA; the Lifetime Achievement Award  
39 from the Alabama Press Association; the Casey Award from the  
40 University of Minnesota; and the Frank Mayborn Award from  
41 Southern Newspaper Publishers Association; he was inducted  
42 into two UA Halls of Fame as well as the Civic Hall of Fame  
43 for the West Alabama Chamber of Commerce; he was named a  
44 Pillar of West Alabama by the Community Foundation of  
45 Tuscaloosa; he was a proud Eagle Scout in the Boy Scouts of  
46 America; and Mr. Boone served on the boards of many  
47 professional organizations; and

48 WHEREAS, Mr. Boone was most proud of being a father  
49 to his five children and being involved in his community; he  
50 was a founding member of St. Paul's Anglican Church in

Tuscaloosa; he served as a board member of many civic organizations: Tuscaloosa Park and Recreation Authority Board, past director and president of United Way of West Alabama, Board of Trustees of the Westervelt-Warner Museum of American Art in Tuscaloosa, past chairman of Salvation Army Advisory Board, past director and president of YMCA of Tuscaloosa, and past president of West Alabama Chamber of Commerce; and

WHEREAS, Mr. Boone was preceded in death by his parents and sister, Jeanette Boone Younkin; he will be remembered by his wife of 36 years, Jane Carolyn Farrior Boone; his children, Kenneth Scholl Boone (Mary Lyman), J. Buford Boone III (Cindy), Lady Martha Frances Boone Cobbold (Henry); Dr. Caroline Boone Rockefeller (Will), and Catherine Boone Hadaway (Harrison); seven grandchildren; and a host of nieces, nephews, other family, friends, and colleagues; and

WHEREAS, although his presence will be greatly missed, the memory of Mr. Boone will be cherished by all who knew and loved him; now therefore,

BE IT RESOLVED BY THE LEGISLATURE OF ALABAMA, BOTH HOUSES THEREOF CONCURRING, That the death of James Buford Boone, Jr. is recorded with deep sadness, and this resolution is offered in tribute to his life, along with heartfelt sympathy to his family, whose grief is shared by
