16 Doctor in 1992; in 1993, he earned a Master of Laws Degree
17 in Taxation from New York University School of Law; and he
18 then joined Balch & Bingham LLP; and

19 WHEREAS, Bo specialized in economic development,
20 nonprofit entity formation, governance, and state and local
21 taxation; he was highly respected for his efforts having
22 been recognized by Best Lawyers in America for his work in
23 economic development law and nonprofit and charity law; and

24 WHEREAS, Bo has been a member of several professional
25 organizations, including the Alabama Bar Association; the
26 Birmingham Bar Association; the American Bar Association;
27 the Economic Development Association of Alabama; the Tax
28 Committee of the Business Council of Alabama; the Business

30 Law Institute; and served as a chair of the Tax Section of
31 the Alabama State Bar; and

33 Entity Code Revision Committee of the Alabama Law Institute
34 will have a lasting and positive impact on the State of
35 Alabama, its residents, and the nonprofit entities doing
36 business in the State of Alabama; and

37 WHEREAS, Bo's expertise was instrumental in updating
38 and improving Alabama's nonprofit laws; he participated in
39 composing the following legislative matters: the Business
40 and Nonprofit Entity Code Revisions Bills of 2014, 2016,
41 2017, 2018, 2019, 2020, 2021, 2022, and 2023; and

43 his children Morgan and William, and was a loyal, loving,
44 and caring husband and father; and
