(over which the city has relinquished control), and
the parking lot located across Union Street to the
rear of the Capitol building between the
administrative building and highway building and

28 Highway Department Building and now designated "the
29 Alabama State House"; and all of that lot bounded by
30 Washington, Jackson, and Ripley ~~and Pelham~~ Streets and
31 McDowell Lee Lane owned by the State of Alabama; and
32 the driveway and parking spaces on the grounds
33 surrounding the Capitol itself; all the aforesaid
34 being exclusive of any right-of-way or rights-of-way
35 or parking facilities now controlled by the City of
36 Montgomery. The Legislature shall be authorized to
37 exercise control over the usage of the ~~said~~ areas
38 through the joint parking committee created by Act No.
39 8, Organizational Session 1975, or its successor, or
40 by subsequent legislative action; and the chief of
41 services of the division of services shall work in
42 cooperation with the Legislature regarding any action
43 taken by the Legislature as hereby authorized."
