4 SYNOPSIS:

5           This bill makes an appropriation of \$169,633  
6           from the State General Fund to the Coalition Against  
7           Domestic Violence for the fiscal year ending September  
8           30, 2025, requires an operations plan and an audited  
9           financial statement prior to the release of any funds,  
10          and requires quarterly and end of the year performance  
11          reports.

17          To make an appropriation of \$169,633 from the State  
18          General Fund to the Coalition Against Domestic Violence for  
19          the fiscal year ending September 30, 2025, to require an  
20          operations plan and an audited financial statement prior to  
21          the release of any funds, and to require quarterly and end of  
22          the year performance reports.

23 BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

24          Section 1. For the fiscal year ending September 30,  
25          2025, there is hereby appropriated to the Coalition Against  
26          Domestic Violence from the State General Fund the sum of  
27          \$169,633. In addition, the appropriation made herein shall be  
28          budgeted and allotted pursuant to the Budget Management Act

29 and Article 4 of Title 41 of the Code of Alabama, 1975, and  
30 specifically Section 41-4-93, Section 41-4-95 and Section  
31 41-4-96.

32       Section 2. Prior to the release of any funds  
33 appropriated under this bill for fiscal year 2025, an  
34 operations plan for fiscal year 2025 and an audited financial  
35 statement for all operations during fiscal year 2023 must be  
36 forwarded to the Director of Finance. It is the intent to  
37 release fiscal year 2025 funds following receipt of these  
38 reports.

39       Section 3. In addition, quarterly reports for fiscal  
40 year 2025 shall be made to the Director of Finance relating to  
41 planned expenditures and accomplishments. An end of year  
42 performance report for the fiscal year 2025 shall be made to  
43 the Director of Finance stating the work accomplished and  
44 services provided and the costs of accomplishing the work and  
45 providing the services, citing meaningful measures of program  
46 effectiveness and costs, as is required for state agencies in  
47 Code of Alabama 1975, Section 41-19-11. The Director of  
48 Finance shall forward a copy of all required reports to the  
49 Legislative Council in a timely manner.

50       Section 4. This act shall become effective October 1, 2024.
