9 (FFA) String Band, a talented country and bluegrass trio  
10 composed of Conner McMeans, Ty McMeans, and Titus Thornton;

12 WHEREAS, blending classic Southern roots with  
13 youthful energy, the group's signature sound features the  
14 banjo, acoustic guitar, and bass guitar, performed with a  
15 heartfelt authenticity that reflects their agricultural  
16 heritage and small-town pride; and

17 WHEREAS, the three musicians first met in an  
18 agriculture class in middle school, where their shared  
19 passion for music and FFA began to take shape; over the past  
20 five years, they have grown together as artists and  
21 performers, captivating audiences across Alabama and beyond;

23 WHEREAS, each member brings a unique background to  
24 the band; Titus Thornton is deeply rooted in a traditional  
25 row crop and cattle operation, while brothers Conner and Ty  
26 McMeans come from a nontraditional agricultural background;  
27 the McMeans brothers operate their own landscaping business  
28 and are avid outdoorsmen, embodying the spirit of

WHEREAS, Conner first picked up the banjo at the age of nine, inspired by one of his teachers who played the instrument; Titus discovered his own love for the guitar and singing around the same time and learned to play bass while in the FFA; Ty followed soon after, learning to fiddle at the age of seven and learning to play guitar four years later; their musical journey has led to countless performances over the years, each one strengthening their bond and refining their sound; and

WHEREAS, beyond their musical success, all three members are highly active in the FFA, serving as chapter officers and competing in a variety of career and leadership development events; together, they have represented the Lauderdale County FFA in contests such as tractor driving, livestock evaluation, and land evaluation, demonstrating their broad agricultural knowledge and leadership both in and out of the spotlight; their involvement showcases the well-rounded spirit of today's FFA members as students who balance artistic talent with hands-on agricultural skills and community leadership; and
