House Bill 388 as introduced would decrease potential future sales tax receipts to the Education Trust Fund (ETF) by the estimated annual amounts listed below, based on information provided by the entities, by extending the state sales and use tax exemption, that would otherwise sunset at the end of the 2026 tax year, for certain community foundations until August 31, 2031.

This bill could also decrease sales and use tax receipts to county and municipal funds, if the respective local governments adopt an exemption from local sales and use taxes pursuant to this bill.
