HJR271 NAMING THE PORTION OF ALABAMA HIGHWAY 21 FROM MILE
MARKER 39 TO MILE MARKER 41 IN MONROE COUNTY THE SPECIAL
AGENT JUSTIN WILLIAMS MEMORIAL HIGHWAY.

WHEREAS, it is with the highest accolade that this
body honors Special Agent Justin Jemel Williams by
requesting the State Department of Transportation designate
the portion of Alabama Highway 21 from mile marker 39 to
mile marker 41 in Monroe County, Alabama, the Special Agent
Justin Williams Memorial Highway; and

WHEREAS, Special Agent Williams distinguished himself
in the Highway Patrol Division of the Alabama State Law
Enforcement Agency (ALEA); after three years with the State
Troopers, he was advanced to the Major Crimes Division in
the ABI/SBI branch of ALEA, serving five years with that
agency and tackling complex criminal investigations; he was
assigned to the United States Marshals Fugitive Apprehension
Task Force, showcasing his ability to collaborate on a
national level; he then served six years in protective
services, serving on the protective details of both Governor
Robert Bentley and Governor Kay Ivey, where he further
distinguished himself in a role that required a high level
of skill to manage often high-stress situations; and

WHEREAS, Special Agent Williams' dedication to law
enforcement is evident in his advancement during his 19
years of service to the State of Alabama, particularly by
continuing to serve on Governor Ivey's protection detail
